RESOLUTION OF THE SOUTH JERSEY TRANSPORTATION AUTHORITY AUTHORIZING THE AWARD OF A CONTRACT TO SCHNEIDER ELECTRIC, OF HORSHAM, PA, FOR THE ATLANTIC CITY INTERNATIONAL AIRPORT CCTV CAMERA UPGRADES

**WHEREAS**, the South Jersey Transportation Authority (the "Authority") was established and created pursuant to the South Jersey Transportation Authority Act (the "Act"), <u>N.J.S.A</u>. 27:25A-1, et. seq.; and

WHEREAS, pursuant to Sections 23 and 24 of the Act, the Authority has become the successor of the New Jersey Expressway Authority and has become the owner and operator of the Atlantic City Expressway (the "Expressway") and the Atlantic City International Airport, (the "Airport"); and

WHEREAS, pursuant to Section 7(x) of the Act, the Authority is authorized to enter into any and all contracts and agreements convenient or desirable for the purposes of the Authority; and

WHEREAS, pursuant to Section 8(a) of the Act, the Authority is required to publicly advertise for bids before entering into contracts for purchases and certain services; and

WHEREAS, on October 14<sup>th</sup> and 15<sup>th</sup>, 2013, the Authority publicly advertised for bids for the Atlantic City International Airport CCTV Camera Upgrades, which encompasses work at the Atlantic City International Airport's terminal and parking lot area to upgrade the existing analog Closed Circuit Television (CCTV) Camera System; and

WHEREAS, on November 19, 2013, six (6) bids were received, opened and tabulated and Schneider Electric of Horsham, PA was deemed the lowest responsive, responsible bidder for the Atlantic City International Airport CCTV Camera Upgrades, in an amount not to exceed One Hundred and Eighty-Eight Thousand Dollars (\$188,000.00); and

WHEREAS, the Acting Executive Director believes it to be in the best interest of the Authority and recommends entering into a contract with Schneider Electric of Horsham, PA, for the Atlantic City International Airport CCTV Camera Upgrades, in an amount not to exceed One Hundred and Eighty-Eight Thousand Dollars (\$188,000.00), pending Public Law 2005, Chapter 51 and Governor Jon S. Corzine's Executive Order #117 approval from the State of New Jersey; and

WHEREAS, entering into the Contract is consistent with the Authority's powers and duties set forth in the Act and the Authority specifically approves the bid specifications, designs and plans.

**NOW, THEREFORE, BE IT** *RESOLVED*, that the Commissioners of the Authority, pursuant to and in furtherance of the powers granted to the Authority under Section 7(x) of the Act, do hereby direct the Acting Executive Director to enter into a contract with Schneider Electric of

Horsham, PA, for the Atlantic City International Airport CCTV Camera Upgrades in an amount not to exceed One Hundred and Eighty-Eight Thousand Dollars (\$188,000.00).

BE IT FURTHER RESOLVED, that a copy of the resolution shall be immediately transmitted to the Governor. Pursuant to N.J.S.A. 27:25A-14, this Resolution shall take effect immediately but no action authorized herein shall have force and effect until the earlier of the passage of fifteen (15) days, Saturday, Sundays and public holidays excepted, after the delivery of the copy to the Governor, or the Governor's approval.

**BE IT FURTHER** *RESOLVED*, that the Acting Executive Director, or his designee, is hereby authorized and directed to take all actions and execute all documents necessary to carry out the purpose of this resolution.

## RESOLUTION OF THE SOUTH JERSEY TRANSPORTATION AUTHORITY AUTHORIZING THE AWARD OF A CONTRACT TO SCHNEIDER ELECTRIC, OF HORSHAM, PA, FOR THE ATLANTIC CITY INTERNATIONAL AIRPORT CCTV CAMERA UPGRADES

**Description:** The project encompasses work at the Atlantic City International Airport terminal and parking lot areas. Major work items include, but are not limited to providing all labor, equipment, and materials to perform all work required for the upgrading of the Airport's existing analog Closed Circuit Television (CCTV) Camera System. The construction will include, but not be limited to mobilization, selective demolition, installation, programming and replacement of the analog CCTV cameras with networked Internet Protocol (IP) CCTV cameras. The replacement IP cameras will tie back to the Airport's existing video CCTV management software. Each analog camera being upgraded will require new home run CAT6 cabling installed to the Airport's main distribution frame, with new power over internet (POE) switches, new copper patch panels and new additional video storage capacity. Designated replacement cameras will be required to be integrated with the Airport's existing access control symmetry software. Additionally, work will also include all labor, equipment, and materials to install new CCTV cameras in certain locations of the Airport parking lot.
