1. I recommend that US Embassy Kabul use other than full and open competition for the acquisition of Hikvision Security Cameras.
2. Proceed with procuring the specific brand name product in lieu of something similar.
3. The Hikvision DS-2CD2232-I5 & DS-2CD2332-I cameras are required as part of a security/accountability measure for personnel accessing and performing duties in network closets and server rooms.

6. These requirements are independent of actual supplier; they can be purchased from multiple sources. The specific manufacturer and model number are the most important aspect of this request.
7. These cameras are in a similar price range of comparable brands.
